50% Off Your First Year Dues As A Classroom Teacher!

ACOE Student Teachers receive a <u>50% Discount</u> off first year membership fees as a Certificated Classroom Teacher Member when upgrading membership from ACOE Student Teacher Member to ACOE Classroom Teacher Member, provided they were an ACOE Student Teacher Member the prior year.

Frequently Asked Questions



- 1. How much does ACOE Student Teacher Membership cost? \$25 for a 12 month membership.
- 2. Do ACOE Student Teacher members receive a discount on their membership fees once they become Certificated Classroom Teachers? YES, ACOE Student Teacher Members who graduate and accept a position with a school system will be granted a 50% discount off their first year fees as a Classroom Teacher Member, provided they upgrade the year following the year they were an ACOE Student Teacher Member. Discounted first year fees will be only \$94.50.
- **3.** Will ACOE Student Teacher Membership protect me once I become a Classroom Teacher? NO, Student Teacher Membership only protects you as a non-compensated Student Teacher. Once you accept a paid position, you will need to upgrade to an ACOE Classroom Teacher Membership.
- **4. Do ACOE Student Teachers have the same member benefits as ACOE Classroom Teachers?** YES! ACOE Student Teacher Members have all of the member benefits that ACOE Classroom Teacher Members have, including \$1 Million Educators Liability Insurance, discounts on goods and services, and other member benefits.
- 5. Does ACOE insurance protect me for something that happened before I joined ACOE? NO. You must have been a member at the time an event happened that resulted in litigation or disciplinary action being taken against you.
